Sub: Updates – Withdrawal of Scheme of Amalgamation of Godawari Energy Limited with Godawari Power and Ispat Limited and their respective shareholders.

This has reference to Outcome of Board Meeting dated 21st May, 2024 vide which we have informed that the Board of Directors have approved the proposal to withdraw the Scheme of Amalgamation due to certain technical reason.
